SIGN SHIELD TERMS AND CONDITIONS

Under ordinary use, and within thirty-six (36) months of the date of purchase of the sign from Prairie Signs, Inc. ("PSI") this limited warranty will cover the repair and/or replacement of all internal electrical components of the sign and the repair and/or replacement of failed or defective graphics in the sign subject to the terms and exceptions stated herein. Upon notification of a claim, PSI will repair any internal electrical component or graphic of the sign that proves to be defective in materials or workmanship. In the event repair of the internal electrical components or graphics of the sign is not possible, PSI will replace the electrical components or graphics of the sign with new electrical components or graphics of similar composition and price. For all purposes of this limited warranty the date of purchase of the sign shall be the date listed on the purchase invoice for the sign issued to the purchaser by PSI.

GENERAL TERMS

This limited warranty shall be provided by PSI for thirty-six (36) months from the date of purchase of the sign as determined by the date listed on the purchase invoice for the sign issued to the purchaser by PSI.

This warranty is provided solely to the original purchaser and is non-transferable. The warranty cannot be assigned, sold, gifted or transferred to any other individual or entity through sale or any other means.

PSI will not be liable to the original purchaser of the sign, or any other individual or entity, for special, indirect, incidental, or consequential damages as a result of, or related to, this limited warranty or any breach thereof under any circumstances.

If, during the thirty-six (36) month period of this limited warranty, any internal electrical components or graphics of the sign are discontinued or are otherwise unavailable for any reason, PSI will replace such discontinued or unavailable components or graphics with components or graphics of reasonably comparable quality. Notwithstanding the foregoing, any difference in appearance in the sign following a repair shall not constitute a violation of this warranty.

It is expressly understood that this limited warranty contains all the terms and conditions of this limited warranty and there are no oral warranties, promises, agreements, understandings, terms or conditions pertaining to this limited warranty other than what is stated herein.

EXCLUSIONS

This limited warranty does not cover fading or discoloration caused by exposure to chemicals, sunlight, rain, sleet, snow, hail or other weather conditions. This limited warranty does not cover damages relating to, or caused by, electrical, structural, or graphic changes or repairs performed by any individual or entity other than an authorized representative of PSI. Any such electrical, structural, or graphic changes or repairs are expressly prohibited and will void and terminate the limited warranty immediately. This limited warranty does not cover damage caused by accidental, willful or negligent acts or omissions of any individual or entity other than an authorized representative of PSI. This limited warranty does not cover damages caused by electrical issues unrelated to the components of the sign, including but not limited to damages caused by: power surges, existing photo cells, time clocks, breakers, or primary wiring. This limited warranty does not cover any damage caused by Acts of God, war, riot, strike, insurrection, fire, terrorism or vandalism. This limited warranty does not cover costs related to access issues or cost of additional equipment required in order to access the sign(s).
